Terms of Use - Website

By using the Site You confirm that you are authorised to provide the personal details presented and You consent to your information being checked with the document issuer or official record holder via third party systems for the purpose of confirming your identity.

These Terms of Use for the Qoin website (the "Site") are entered into by and between You and BPS Financial Pty Ltd ("BPS") and together with any other documents which expressly incorporate the Site. These Terms of Use govern your use of the Site and any Services BPS provides.

By using the Site or by accepting or agreeing to the Terms of Use You accept to be bound by these Terms of Use, the Privacy Policy, the Product Disclosure Statement ("PDS") the Financial Services Guide ("FSG") and all other terms incorporated by reference, as well as any applicable legislation that cannot be excluded at law. These all form an agreement between You and BPS ("Agreement"). If You do not agree to the terms of the Agreement, You must not access or use the Site.

BPS reserves the right to amend the Agreement in relation to these Services. Your continued use of the Site means You accept and agree to the amendments.

1. Definitions

In this Agreement:

Algorithm means a process or set of rules to be followed for calculations of the Qoin value. Calculations are based on the average spare capacity of validated merchants to redeem a Qoin for goods and services. The spare capacity of a Qoin Merchant is initially calculated as an average business turnover of \$US500,000 per annum, multiplied by a spare capacity factor of 25%.

Blockchain means a distributed ledger of records organised into blocks that are linked together using cryptographic validation. When a block is added to the chain, it cannot be changed without affecting all blocks that came after it, this creates an immutable data file that no single entity controls.

BPS, 'we' or 'us' means BPS Financial Pty Ltd ABN 99 604 899 381.

Cryptocurrency means a digital currency in which cryptography encryption techniques are used to regulate the generation of units of currency and verify the transfer of funds.

Directory means a service available on the Site that contains the names and such other information concerning participating Qoin Merchants that BPS from time to time determines.

Intellectual Property Rights means all industrial and intellectual property rights, both in Australia and throughout the world, and includes any copyright, moral right, patent, registered or

unregistered trade mark, registered or unregistered design, registered or unregistered plant breeder's right, trade secret, knowhow, right in relation to semiconductors and circuit layouts, trade or business or company name, indication or source or appellation of origin or other proprietary right, or right of registration of such rights.

Packs means a collection of Qoins which can be purchased by a Qoin Merchant.

Qoin means the cryptocurrency on the Q Chain.

Q Chain means the Qoin Blockchain.

Qoin Merchant means a merchant who is listed in the Directory who uses the Qoin Wallet to process Qoin Transactions in order to complete a sale of their goods and/or services and in doing so agrees to accept Qoin at the value determined by the Algorithm.

Qoin Transactions means transactions between You and a Qoin Merchant through the Qoin ecosystem and/or peer to peer transactions, conducted through participating digital currency exchanges.

Qoin Wallet or **Q Wallet** means a cryptocurrency wallet developed by BPS that connects to the Q Chain, stores a user's Qoin and allows a user to make Qoin transactions within the ecosystem and to trade Qoin on participating digital currency exchanges

Services means the services, including the Site, the Q Wallet, Transaction Services, sites located within the Directory provided by BPS to You.

Transaction Services means services provided by BPS (through the Qoin Wallet) to facilitate Qoin Transactions between You and a Qoin Merchant.

You means the user who utilizes either or both of the Qoin Wallet and the Site.

2. Access and use of the Site

BPS will use best efforts to maintain the availability of the Site but does not guarantee that the operation of or access to the Site will be uninterrupted or continuous. The Site may be interrupted for maintenance, repairs, upgrades and network or equipment failures.

BPS reserves the right to disable or amend the Site and any Services available via the Site. To the extent permitted by law. BPS will not be liable if for any reason all or part of the Site is unavailable at any time. BPS may restrict access to some parts of the Site, or the entire Site to You.

14. Governing Law

Any disputes against BPS, arising out of or related to the Agreement and/or any use by You of the Site shall be governed by the laws of the State of Queensland without regard to its choice of law rules and without regard to conflicts of laws principles.

15. Dispute Resolution

You and BPS agree that in the event of a dispute arising out of the Agreement both parties will first attempt to resolve the dispute by direct discussion or negotiation. If within thirty (30) days a mutual agreement cannot be reached between the parties, the parties may refer the matter to an independent mediator agreed upon by the parties and both parties agree to split the costs of appointing a mediator between them. The appointment of a mediator is solely at the discretion of the parties and if a party so wishes, a party may obtain their own legal advice in respect of the dispute without nominating a mediator.

16. Waiver and Severability

BPS will not be in breach of these Terms of Use if we take necessary action in order to make a change necessitated by an immediate need to restore or maintain the security of the system.

21. Confidentiality

BPS will not collect, record or otherwise deal in commercially sensitive information, except to the extent necessary to process the Qoin Transactions, or as otherwise set forth in the Privacy Policy.

22. Third Party Links and Websites

The Site may contain links or portals to third party websites not under BPS' control or operation. Any such links are provided only as a convenience and do not imply BPS' endorsement or responsibility for the contents of any such linked site. Qoin Merchants may list their business in the Directory to notify and advertise the goods and services they sell by accepting Qoin as payment.

25. Payments and Fees

BPS' current Transaction Services and Services do not incur any fees. However, BPS may charge fees in the future and will provide notice of the same.

26. Transactions

Once transaction details have been recorded, BPS cannot assist You to cancel or otherwise modify your transaction.

Qoin Merchants may accept payment for the sale of their goods and services in Qoin.

You must ensure You have an adequate balance in your Q Wallet to complete a transaction before initiating a transaction.

You acknowledge and agree that BPS will not be liable for any failed transactions due to insufficient funds associated with your Q Wallet.

27. Modifying or updating the App and Site

BPS may modify the Site from time to time. When this occurs, the features of the Site may change, and some existing features may be removed. BPS may not provide You with advance notice of any changes.

28. Integrations

BPS integrates with third party software to provide a full suite of functionalities. BPS is not responsible for any issues or loss arising from the use of any third-party software. Your access and use of the third-party software are governed by the terms of service or user agreements of that software.
